

Human Trafficking Definitions

What is Human Trafficking?

The recruitment, transportation, transfer, harboring or receipt of a person, by means of the threat or use of force, fraud coercion, or deception for the purpose of exploitation.

- Trafficking Victims Protection Act (Federal Law)

*Force, fraud and coercion are not required for minors under the age of 18 induced into commercial sex acts

ACTION

-RECRUITS -TRANSPORTS -PROVIDES -OBTAINS/ATTEMPTS MEANS

PURPOSE

-COMMERICAL SEX ACTS -LABOR SERVICES * Force, fraud and coercion are not required for minors under the age of 18 induced into commercial sex acts

What is Domestic Minor Sex Trafficking?

According to Public Law-110-457, domestic minor sex trafficking (DMST) is defined as "the commercial sexual exploitation of US and legal alien children, under the age of 18 years of age, within US borders"

Experts estimate at least 100,000 American juveniles are victimized through prostitution in America each year. DMST includes but is not limited to the commercial sexual exploitation of children through prostitution, pornography, and/or stripping.

Commercial Sex Exploitation

Terminology:

Commercial – refers to industry, trade, money

Sex – any sex act

Exploitation – the use of power, authority or privilege to induce an activity or behavior; akin to force, fraud, or coercion.

Human Trafficking Laws & Impact

Human Trafficking Laws

- 1. United Nations Article 9.5 in the Palermo Protocol
- "to discourage the demand that fosters all forms of exploitation of persons"
- 2. Trafficking Victims Protection Act (Federal)
 - as an amendment to the Violence Against Women Act
- 3. Act 105 (Pennsylvania)
 - increases punishments for traffickers
- 4. **Safe Harbor** (NOT passed yet)
- 5. **Prostitution Crimes Code** (Pennsylvania)
- 6. **SESTA** (Federal)

Impact of Human Trafficking


- Fastest growing criminal industry worldwide
- Second largest criminal industry in the world
- 80% of trafficking victims are women and girls
- •50% of trafficking victims are minors (underage)
- 40% of homeless youth identify as LGBTQ



Recruitment Tactics

- Seduction and romance
- False job adventures
- Lies about educational or travel opportunities
- Abduction
- Sale by family
- Recruitment through former slaves

Youth Indicators

- Variable school attendance
- Traveling to cities/familiarity with transportation from city to city
- Delinquency
- Tattooing
- Excessive & expensive possessions (clothing, shoes, handbag)

2012 Case

- Vincent C. George, Jr. and Sr., father and son, arrested for multi-million dollar sex trafficking ring
- Both men faced possible sentences of 25 years for several counts of sex trafficking
- Neither men were found guilty based on testimonies from prostitutes stating that the men made them feel like family
- The women testifying said they were treated to nice cars, vacations in Florida and affection from their pimps. Some lived together as "family" in a house in Allentown, about 90 miles from New York, and drove in to the city at night to turn tricks for \$300 a night.



2014 Case

Two Admit Role in Allentown Prostitution Ring

The Morning Call, January 13, 2014

Daniel Blount, 31, and Deshawn King, 34, assaulted and raped the women when they tried to leave, kept most of the money the women earned performing sex acts, and withheld drugs to control the women.

"The defendants in this case preyed on vulnerable women, dehumanized them, threatened and abused thme, and sold them for profit", U.S. Attorney Zane David Memeger said in a news release. "These defendants made a living thorugha horrific form of modern day slavery".

Vulnerability Factors

- Foster system
- Homelessness and "runaway" lifestyle
- Couch surfing (type of homelessness)
- Youth in group home living situations
- Childhood sexual abuse: 90% of trafficking victims have a history
- Poverty the illusion of breaking the glass ceiling & inability to meet basic needs

- Dope-sickness
- Single motherhood
- Trauma or mental health instability
- Developmental stage/age
- Unstable home environment
- Misidentification
- Glamorization of prostitution

Vulnerable Youth: Strip Club Pipeline

Allentown Case Example:

The Platinum Plus investigation began when the Bureau of Liquor Control Enforcement got an <u>anonymous complaint</u> about possible prostitution.

- Champagne room \$300
- Champagne room = lap dances on a couch in a cubicle
- Uncorked bottle = menu of sex acts
- 11 women arrested: 4 of them 18/19 years old

Locations:

- Bethlehem
- Easton
- Lehighton




2017 Case

"Female residents also were pressured into sex acts with Edmonds in exchange for heroin, including an encounter with a 16-year-old girl that was recorded on Edmonds' cell phone, police say."



Cash or Credit?

Pimps operate mostly in cash, but some accept other forms of payment for sex.



Commercial Sex Market – "The Demand"

Basics of Demand

Supply and demand is made up of 3 basic parts, often referred to as the triangle


- Demand: Individuals buying sex
- Supply: Bodies are commodities/raw goods
- **Distribution:** Traffickers

- Sex Trade Commercial Sex Industry
- Pornography

Major vehicle in trafficking economy is the internet

76% of victims are recruited and groomed online



Social-Sex Economics

Men who buy sex do not value women*

Demand (Buyers)

Supply (Bodies)

Supply: Raw Goods, Materials, Commodity

The Law of Demand

"the higher the price of a good, the less people will demand that good"

Supply – Victims' Social Vulnerability

- Foster youth
- "Runaway" youth
- Youth in group home living situations
- •90% of victims have a history of childhood sexual abuse
- Poverty & glamorization of prostitution the illusion of breaking the glass ceiling
- Dope-sick victims
- Single mothers

Demand – Buyers' Social Context

47% of prostitutes in one study said they had been harmed by men who tried to force their victims to do things the men had seen in porn

--Melissa Farley (2009)

"Men who buy sex: Who they buy and what they know"

16% of men in the U.S. have paid for sex

49.2% of sex buyers in one sample had never discussed their buying of sex with anyone else



Demand Economy

- □ 1 out of 7 men
- ☐ 743,000 PA who purchase sex or continue to purchase sex
- □ 18-23 first experience buying
- □ 75% Occasionalists, less than 3x a year
- □ 20% Regulars, upwards of 15x a year
- □ 5% Habituals, 75+ transactions a year

County or Region's Adult Male Population X .14 = best estimate of annual sex buyers

Trauma & Development in Youth

How to Respond!

Interactions:

- Be casual
- Isolate when possible
- Ask careful questions related to indicators
- Don't call/text without explicit permission
- Check YOUR choices!

Victim-Centered Approach:

- Reassurance of help
- Build trust & rapport
- Be conscious they are NOT criminals, but don't identify as victims
- Relationship patience
- Advocacy for collaboration – unified!

Messages:

- We are here to help.
- Your safety is our first priority.
- You have a right to live without being abused.
- You have rights.
- Help is available.

Advocacy

Mutual: The relationship between the client and the advocate is reciprocal, interdependent, joint, and equal; they exchange ideas and plans together, proceeding in an agreed-upon direction. Included in the term, mutual, is also the notion of empowerment that not only enables the clients to carry out an activity, but also motivates them and teaches them skills required to interact with the environment
