Questions

- Incidents can happen know matter how well we plan. Is there anything that may have prevented or changed the events of the encounter?
- Field visits can sometimes put us in difficult situations. Do you believe that field contacts should be conducted in pairs or solo? What about locations and time of day?
- What program or procedures does your department have in place to address the physical and emotional effects of such an incident?
- What does the incident tell us about the importance of being ready for anything on the street? How can you prepare yourself to win and survive?
- When arriving at an offender's residence, where is the best place for an officer to park his/her vehicle?
- How do environmental factors (parking, danger of neighborhood, weather, etc.) affect contacts with offenders?
- Could this incident have evolved into a deadly force encounter?
- As Probation Officers, sometimes we may feel we are not targets, but this incident proves otherwise. How do we plan for these kind of events?
