





Strategy 4: Family and Kin



Family Finding – PA Law

Pennsylvania's Act 14 of 2019 ensures that family finding occurs on an ongoing basis for all children entering the child welfare system both court active & non-court active cases.

The law is also intended:

- (1) identify and build positive connections between the child and the child's relatives and kin;
- (2) involve relatives and kin in children and youth social service planning and delivery;
- (3) create a network of extended family support to assist in remedying the concerns that led the child to be involved with the county agency.

Courts are required to:

- 1. Inquire as to the efforts made by the county agency to comply with the family finding requirements pursuant to the law
- 2. Place its determination on the record as to whether the agency has reasonably engaged in family finding
- 3. Court inquiry and determination should be made at each stage of the case

Rule 1149

4 Steps of the FGDM Process

- 1. Referral
- 2. Preparation
- 3. FGDM Conference
- 4. Follow-Up




FGDM Conference: 3 Most Important Components

- 1. Sharing of Strengths and Concerns, including bottom-line concerns
- 2. Private Family Time
- 3. Presentation of the Plan


