**Governor Presents Executive Budget** 

overnor Rendell presented his FY '06-'07 Executive Budget to the General Assembly on February 8, 2006. The Governor proposed that both the Improvement of Probation Services and the Specialized Probation Services (SPS) appropriations be funded at FY '05-'06 levels of \$5,918,000 and \$13,793,000 respectively. The SPS appropriation is currently supporting approximately 378 specialized juvenile probation officer positions.

CJC Standards Governing the Administration of Restitution Funds were published in *The Pennsylvania Bulletin* (36 Pa.B. 957) as a Statement of Policy on February 25, 2006. The standards are intended to provide guidance to president judges of courts of common pleas regarding the administration of restitution funds.

The JCJC developed these Standards in conjunction with the Standards Committee of the Pennsylvania Council of Chief Juvenile Probation Officers, to provide guidance to judges in the implementation of Act 217 of 2004. Act 217 included amendments to the Juvenile Act at 42 Pa. C.S. §6352(a)(5) to provide that the court may order payment by a delinquent child of reasonable amounts of money as fines, costs, fees or restitution as deemed appropriate as part of the plan of rehabilitation considering the nature of the acts committed and the earning capacity of the child, including a contribution to a restitution fund. Additionally, §6352(a)(5) requires the President Judge of the Court of Common Pleas to establish a restitution fund for the deposit of all contributions to the restitution fund which are received or collected, and to promulgate written guidelines for the administration of the fund. Disbursements from the fund must be made, pursuant to the written guidelines and the limitations of the Juvenile Act, at the discretion of the President Judge and used to reimburse crime victims for financial losses resulting from delinquent acts.

Act 217 also amended the Juvenile Act at \$6323 and \$6340 to provide that the terms and conditions of an informal adjustment or a consent decree may include a contribution to a restitution fund established by the President Judge. The Act also created \$6304.1 "Summary offenses", which provides for the option of contributions to a restitution fund in cases where a child has failed to comply with the lawful sentence imposed for a summary offense.

The Standards include specific provisions in the written guidelines that include the following: disbursements from the fund shall require the signatures of at least two persons designated by the president judge; a policy requiring an annual report, detailing the aggregate and individual data regarding payments to and disbursements from the restitution fund; and a requirement for an annual audit, pursuant to county policy, of all payments to and disbursements from the fund.

# Education Law Center to Develop Educational Aftercare & Reintegration Toolkit

hrough the support of the MacArthur Foundation and the Pennsylvania Commission on Crime and Delinquency, along with many other entities, the Aftercare component of Pennsylvania's Models for Change initiative continues to progress. Efforts to gather information about current practice and procedure within the state have allowed for the identification of a number of issues in need of systemic attention. One of the most common issues is the problem associated with the transition of students from residential educational programs back into their home school districts. Virtually every county has identified problems in this area, with many listing school reintegration as the primary barrier to seamless transition from facilities to home communities.

As part of the response to this issue, the Education Law Center is in the process of developing an *Educational Aftercare & Reintegration Toolkit*, a resource guide that will be distributed to juvenile probation officers throughout the state. The Toolkit is being developed by Shari Mamas, Staff Attorney with the Education Law Center, along with input from a variety of sources involved with the Aftercare Project. The "Toolkit" will contain information designed to increase knowledge on a procedural and legal level, as well as to provide information about technical assistance available to probation officers and their departments in dealing with these matters.

The Toolkit is expected to be completed sometime in March, at which time the five Aftercare "Model Counties" will be trained with a curriculum being developed in conjunction with the Toolkit. Following this, the Toolkit will be widely distributed and regional training will be provided to all juvenile probation departments and staff. Additional training venues are also being considered.

#### **Staff Development News**

s we enter the busiest portion of the spring training season and approach the close of the current training year, staff and supervisors are reviewing progress toward meeting the minimum annual training requirement. Several workshops still have space available

"Basics of Adolescent Substance Abuse: Trends, Interventions and Referral Skills" (#23) scheduled for June 7-8 at the Days Inn Penn State still has limited space available for additional registrants.

A one and one-half day workshop entitled "Successful Employment: A Modality to Behavior Change" (#20) will be held on May 17-18, at the Days Inn Penn State. This program will provide participants the opportunity to become more effective at helping youth to prepare to enter an employment situation, be more effective job seekers, and enhance the chances that they will be successful in staying employed once they have gotten a job. This workshop will teach a critical repertoire of skills that are especially important for older youth. The session will be led by Cameron Ford and Courtney Hoppe of the New Hampshirebased MY TURN program, an education and career exploration/job preparedness program. MY TURN is a nationally recognized, award winning youth development program that was also recognized by the PEW Charitable Trust as one of the 19 "Solutions for America."

On the same days, May 17-18 at the Days Inn Penn State, the Center is also sponsoring another workshop entitled "Enhancing Decision-making Competencies with the Facts of Life Seminar" (#21). This workshop will teach participants how to lead a group of adolescents through a structured program designed to develop pro-social decision-making competencies. This program model was developed by Dr. Douglas R. Ramm, a Westmoreland County board certified clinical psychologist who been using this model with delinquent adolescents in his area for many years with very successful outcomes. Dr. Ramm has already taught scores of professionals to do the same. Running competency development groups with our clients is what our system staff should be doing more in order to enhance our outcomes. This is one of several model that has demonstrated promise.

## **2006 Safe Schools Conference**

#### **Aftercare Forum Held**

n December 1-2, 2005, an Aftercare Forum developed in conjunction with Pennsylvania's *Models for Change* initiative, was held at the Days Inn, State College. Over 75 registrants, representing 27 juvenile probation departments and 14 other agencies participated in this event. The forum began with a presentation regarding the *Models for Change* initiative by Autumn Dickman of the Juvenile Law Center. Ms. Dickman reviewed the Disproportionate Minority Contact and Mental Health / Juvenile Justice Coordination components of the initiative, in additional to the goals of Aftercare.

The first day of the Forum contained various presentations regarding Aftercare. Rick Steele and Kelly Franklin, Aftercare Specialists with the Juvenile Court Judges Commission and the Pennsylvania Council of Chief Juvenile Probation Officers, reviewed the Joint Policy Statement on



Aftercare. Pat Torbet and Doug Thomas of the National Center for Juvenile Justice (NCJJ) reviewed the stages of Aftercare, the Competency Development White Paper, and information regarding the use of screening and assessment instruments. Candace Putter and Marna Ferster, of the Philadelphia Reintegration Initiative, led the group through an exercise aimed at developing appropriate Aftercare treatment plans. The first day ended with a presentation by Michele Ambruch describing the connection between the Communities That Care Initiative and Aftercare.

The second day featured presentations by the four Aftercare Model Counties currently funded through the Pennsylvania Commission on Crime and Delinquency (PCCD). Steve Vajda introduced York County's Intensive Aftercare Model, and reviewed the project activities and phases involving each youth. Cindi Wess and staff from Goodwill Industries described Cambria County's partnership with Goodwill Industries, where youth are involved in

an in-depth job skills / job readiness project that includes individual assessment and a variety of work experiences for each participant. Russ Carlino, from Allegheny County, introduced members of his Educational Specialist staff, who informed the group of their progress in working directly educational staff in residential programs to facilitate educational reintegration and credit transfer issues. Mr. Carlino also discussed Allegheny County's placement decision-making guidelines, which offer a structured and consistent manner for staff to make placement recommendations. Finally, Ed Robbins reviewed Lycoming County's project which focuses on strategies to support and strengthen family involvement for youth in placement and upon their release.

The Aftercare Forum was well received by those in attendance. ### Carol Lavery Confirmed As Pennsylvania's Victim Advocate

arol Lavery was confirmed as
Pennsylvania's Victim Advocate on February 15, 2006, after being nominated by
Governor Rendell for that position on January 3,
2006. As Pennsylvania's Victim Advocate, Ms.
Lavery is responsible for directing the operations of the Office of Victim Advocate, located within the Pennsylvania Board of Probation and Parole.

Ms. Lavery previously served as the Director of the Office of Victims' Services (OVS) within the Pennsylvania Commission on Crime and Delinquency (PCCD), a position that she held since 1996. As such, she was responsible for the allocation of over \$30 million in federal and state grant funding to community-based victim service centers, district attorneys offices and juvenile probation offices.

She was responsible for the oversight of the Commonwealth's Crime Victims Compensation Program. Under her leadership at PCCD, the Crime Victim Compensation Program increased claims more than 100 percent, while at the same time reducing the amount of time that a victim must wait for compensation from an average of 26 weeks to 8 weeks.

She has overseen a variety of initiatives, including the creation of one of the first state Victim Assistance Training Academies in the nation, and the state's prestigious Governor's Pathfinder Awards Program for outstanding victim service professionals. In the aftermath of the September 11th terrorist attacks, Ms. Lavery was responsible for the development and funding of services for Pennsylvania residents directly victimized or who lost family members in the New York and Pentagon attacks, and for surviving family members of those killed in the Shanksville crash of Flight 93. She has been a leading force behind victim-related legislation, including enhanced rights for victims of juvenile crime and increased victim compensation benefits.

She is currently the President of the Board of Directors of the National Organization of Victim Assistance, a Board member of the National Association of Victim Assistance Administrators, and an Advisory Board member of the National Criminal Justice Association. She is a founding member and former President of the Pennsylvania Coalition Against Rape, and a founding member of the Coalition of Pennsylvania Crime Victim Organizations. For 17 years, she was the Executive Director of the Victims Resource Center of Luzerne and Wyoming Counties, an organization that she helped found in 1974. She holds a Masters Degree from Marywood University and a Bachelor's Degree from Wilkes University.

### DPW to Relocate Southwest Secure Treatment Unit to South Mountain Restoration Center

he Department of Public Welfare has an nounced that South Mountain Secure Treat ment Unit (SMSTU), currently operated by Cornell Companies, Inc., will cease to operate as a state-contracted facility effective June 30, 2006. The Southwest Secure Treatment Unit (SWSTU), a state-operated facility, will relocate to the grounds of the South Mountain Restoration Center in place of the SMSTU.

According to Anne Marie Ambrose, Director of DPW's Bureau of Juvenile Justice Services, the discontinuance of the South Mountain Secure Treatment Unit's contract and the relocation of the Southwest Secure Treatment Unit to the South Mountain Restoration Center are the result of implementing cost-saving initiatives through reorganization. The Bureau of Juvenile Justice Services will work individually with juvenile probation departments to coordinate the placement plans for all juveniles under commitment to the SMSTU and SWSTU.

#### 2006 JCJC AWARDS PROGRAM
