### ARC Hosts African American History Fair

On February 23, 2010, Alternative Rehabilitation Communities (ARC) hosted its Fifteenth Annual African American History Fair at the Crispus Attucks Community Center in York.



Students from each of ARC's nine facilities, as well as more than 50 invited guests, attended this year's program.



The fair is traditionally the biggest event of the school year for ARC's students and staff, as they spend considerable time researching, learning and preparing for the program.

Approximately 125

ARC students actively participated in this year's fair by entering projects in one of six categories: 1) Exhibit, 2) Art, 3) Visual Arts, 4) Research, 5) Dramatic Performance, and 6) Musical/Dance Performance. Judges were chosen from

among the invited guest and medals were awarded to the students whose projects received the highest scores. Projects from the Exhibit, Art, Visual Arts, and Research categories were prominently

displayed throughout the hall for students and guests to review at their leisure. The projects displayed the students' creative abilities, while also being informative and educational, as the projects highlighted both pioneers and current African American leaders in various disciplines – from science to politics to education to athletics.

The day started with a Welcome from ARC's CEO, Daniel Elby. Mr. Elby explained the

significance of the annual event to his students, not only in recognition of Black History Month, but also in developing critical competencies.

"Participation in this event helps increase their [the students] self-esteem and helps them realize that they can learn and achieve, despite prior experiences".

After two musical selections by ARC's student gospel chorus, the competition in the Dramatic Performance and Musical/Dance Performance categories began. In total, there were twenty-five dramatic performances (skits, monologues and poems) and five musical performances presented for the audiences' entertainment. The students





showed incredible courage and talent as they performed on stage in front of a packed house. Following lunch, which featured many traditional African American dishes, the students participated in African American History Jeopardy, as well as several other educational activities in smaller break-out groups.





### Educational Aftercare & Reintegration Toolkit On-line Training Course for Juvenile Justice Professionals

The Education Law Center (ELC) is offering a new on-line training course based on its *Educational Aftercare & Reintegration Toolkit for Juvenile Justice Professionals*. Many juvenile justice professionals across Pennsylvania have already attended in-person trainings based on this *Toolkit*. Thanks to support from the John D. and Catherine T. MacArthur Foundation, ELC is now able to offer an on-line version of this training to juvenile justice professionals who are new to the field or who are unable to attend a live training.



The on-line training covers a wide variety of issues that impact youth involved in the delinquency system, include school enrollment, attendance, truancy, school discipline, and special education issues. The course includes ten quizzes which allow the user to interact with the course material.

### This training course is free. There are no tuition fees or registration costs.

You will receive **four (4) credit hours** upon completion of the course. If you want to receive the credit hours for this course, you must complete the **entire** course, including all the quizzes. At the end of the course, you will be asked to provide an e-mail address for your department's training coordinator, your chief, your supervisor, or other appropriate person to whom notification of your completion of the course should be sent.

As a school-based juvenile probation officer, it was good information to have to understand my role with the reintegration of juveniles placed in our system.

### 2010 JEJE AWARDS PROGRAM

The Juvenile Court Judges' Commission is pleased to announce that nominations are now being accepted for the 2010 JCJC Awards Program. This year, the award categories will include:

**RESIDENTIAL PROGRAM OF THE YEAR** - honors any public or private sector program serving alleged and/or adjudicated delinquent youth in a residential setting.

**COMMUNITY BASED PROGRAM OF THE YEAR** - honors any public or private sector program which provides community-based non-residential services to alleged and/or adjudicated delinquent youth.

**JCJC MERITORIOUS SERVICE AWARD** - honors a volunteer who works with alleged and/or adjudicated delinquent youth.

**JCJC VICTIM ADVOCATE OF THE YEAR AWARD** - honors an individual who works on behalf of crime victims as a victim advocate in county government or in a community-based agency.

**JUVENILE COURT SUPPORT SERVICE AWARD** – honors an individual who provides secretarial support services to the juvenile court. This includes receptionists, secretaries, clerk/typist, office managers and others functioning in a similar capacity.

Chief Juvenile Probation Officers may nominate programs or employees for all of the above award categories. However, individuals must be nominated from the county in which they are employed, and all nominations must be submitted by county juvenile probation departments. Providers may contact chief juvenile probation officers in an effort to have a program nominated. Nominations must be postmarked by April 23, 2010.



### Equipping Supervisors to Maximize Officer Effectiveness

### Ed (Schmook) Shearn Retires

Ed (Schmook) Shearn has retired as Chief Juvenile Probation Officer for Schuylkill County effective January 15, 2010. He had been employed in various capacities as a juvenile probation officer in Schuylkill County for 34 years.

Ed commenced his employment as a probation officer when he was charged with the recruitment and supervision of a foster care program operated jointly by the Loysville Youth Development Center and the Schuylkill County Juvenile Probation Department. Subsequently, he undertook the responsibilities as intensive probation officer and progressed through the administrative positions of Supervisor and Deputy Chief. While Deputy Chief, Ed provided aftercare services to juvenile offenders in placement.

Ed had served as a member of the Schuylkill County Drug and Alcohol Executive Committee, on the Youth Council of the Luzerne/Schuylkill Workforce Investment Board, and was active in the Pennsylvania Council of Chief Juvenile Probation Officers. Most recently, he served as chairman of the By-Laws Committee and as a member of the Council's Executive Committee. He had previously been involved with the Public Relations and Standards Committees and worked on the redesign of the Juvenile Court Judges' Commission (JCJC) statistical card. From 1988 through 1989 he served on the Compliance Review Team for secure state facilities.

A 1975 graduate of Kings College with a Bachelors Degree in Criminal Justice, he is a graduate of the JCJC sponsored Masters Degree program in Administration of Justice at Shippensburg University.

His future plans are to travel with his wife Marilyn and to pursue other leisurely endeavors.

The Juvenile Detention Centers' Association of Pennsylvania (JDCAP) extends an open invitation to all interested persons to participate in a panel discussion on "The Future of Juvenile Detention."

The panel discussion will occur on Thursday, April 1, 2010, from 10:00AM to 12:30PM at the County Commissioners Association North Office and lunch will be provided immediately following the panel discussion. This event will also be broadcast by webinar to various Pennsylvania juvenile justice stakeholders.

The purpose of this panel discussion will be to provide an overview of the current trends impacting juvenile detention, as well as to develop strategies for assuring that detention professionals move forward in a way that best meets the needs of youth and communities. As the juvenile justice system has been experiencing fewer referrals (fewer arrests), more effective use of detention alternatives, and improved expediency in finding services when youth are temporarily detained, the result has been both a decreasing number of referrals and/or decreasing lengths of stay in detention. However, it remains critical to ensure accessibility and excellence in service delivery when detention is required.

JDCAP looks forward to engaging various experts in the field in a discussion geared towards protecting the future. ### February 25, 2010 - Fact Sheet Confirms Continued Decline in Number of Juveniles in Residential Placement


The Office of Juvenile Justice and Delinquency Prevention has published "Juveniles in Residential Placement, 1997–2008." Data cited in this fact sheet are derived from the Census of Juveniles in Residential Placement and the Juvenile Residential Facility Census, both of which include 1-day counts of the juvenile placement population.

As the fact sheet confirms, the number of juvenile offenders in residential placement in publicly and privately operated juvenile facilities has declined steadily since 2000. In 2008, fewer than 81,000 juvenile offenders were housed in residential facilities at the time of the census, the lowest number since 1993.

## THE HONORABLE JOHN B. LEETE BECOMES SENIOR JUDGE: POTTER COUNTY GETS NEW PRESIDENT JUDGE



The Honorable John B. Leete was confirmed by the Administrative Office of the Pennsylvania Courts as Senior Judge in December 2009. Having been sworn into office on February 19, 1988, Judge Leete spent the next twenty-two years fulfilling his responsibility to the people of Potter County and the Commonwealth of Pennsylvania by applying the Rule of Court, case law and statutes in a fair and impartial manner.

Upon completing his legal stud-

ies at the University of Pittsburgh, Judge Leete served with Neighborhood Legal Services in Allegheny County before returning to Potter County to establish a successful private practice.

During his tenure on the bench, Judge Leete has served several terms on the Juvenile Court Judges' Commission. He is recognized as having made a personal commitment to the advancement, safety and well being of each of the youth who have appeared before him. In addition, he has served as a member of the Pennsylvania Bar Association, American Bar Association, Pennsylvania Conference of State Trial Judges, Rotary International and other local organizations.

Likewise, Judge Leete became active in the Yellow Ribbon Teen Suicide Prevention Program, assisting in the acquisition of a \$75,000.00 grant to aid in teen suicide prevention in Potter County. He has actively expanded his commitment to the cause of teen suicide prevention in various locations throughout the Commonwealth.

Prior to accepting status as Senior Judge, Judge Leete was an Adjunct Professor of Criminal Justice Administration at Mansfield University, where he admits an effort to recruit quality students into the field of juvenile justice.



On Monday, January 4th, Stephen P. B. Minor was sworn into office as President Judge of the Potter County Court of Common Pleas. A native of Potter County, Judge Minor received a Bachelor's Degree in Regional Planning at Mansfield University. He completed his legal studies at Oral Roberts University in Oklahoma and returned to Pennsylvania, where he spent the next five years at private practice in Washington, PA.

Judge Minor relocated to Potter County and established a private practice in both McKean and Potter Counties for the next eighteen years. For the past fourteen of those years, he served as Juvenile Court Master for the McKean County Court of Common Pleas, presiding over dependency and delinquency hearings.

Judge Minor has been a member of the Pennsylvania Bar Association, Inn Of Courts, Rotary International, Pennsylvania Association for Justice, and McKean/Potter Counties Chapter of the American Red Cross where he served as a member of the Board of Directors and past Chairman.
